### **HIGHLIGHTS: Kansas Complete Count Committee Training Overview**

\*Primary objective is to form local government CCCs, however, the Census Bureau encourages community leaders in hard-to-count areas to form CCCs as well.

\* Identifying hard to count areas- African American communities

\* Congressional seats gains or losses by Census #. Texas may gain an additional 3 congressional seats after 2020 census.

\*Kansas in FY2016 Kansas received \$6,054,507,586 through 55 federal spending programs.

Note: ED Cox is serving on the Kansas Complete Count Committee. 1<sup>st</sup> official training to place in August.


The following information is submitted for the KAAAC Quarterly Reporting for District 4 – Kansas – Commissioner Joseph Elmore– March-May 2019
